# SOLID WASTE Craig Cameron

In accordance with PA Act 101, Blair County has been working on its 10 year municipal waste plan. Three alternatives have been discussed including recycling, composting, and land filling. Recycling will be implemented first involving several techniques. They include curbside collection, drop off center or materials recovery facility (MRF), buy back center where recyclables are taken and payment is received, and last, special programs for office paper and commercial establishments. A survey has been mailed to the 24 municipalities to receive each one's preference. Bids have also been advertised for various recycling equipment to be used at a MRF. Pennsylvania has mandated that Altoona and Logan Township begin recycling by Sept. 25, 1990. Recycling is simple to do to help our environment and reduce waste going to the land fill. Instead of pitching trash into the garbage can, pitch it in a recycling bin. More on composting and land filling later.

#### PENNSYLVANIA BIRDS Marcia Bonta

As I related in the Gnatcatcher last spring, I am now the Blair County compiler for Pennsylvania Birds. If you have an unusual sighting of a bird in the county, please call (684-3113) or write to Marcia Bonta at Box 68, Tyrone, PA 16686 with the species, date and place where you saw the bird. My summer report for the months of July, August and September is due by the middle of October so please be prompt. Although I use some discretion in the number and species of birds I report, I try to include the most important sightings of every reporter. But it is up to the editors, Frank and Barb Haas, to make the final decisions as to what will or will not be published. So don't be discouraged if all the birds you report are not published in the magazine. Many of mine aren't either but that doesn't mean you shouldn't do your best both in your initial observations and in your reports. The only way we can come up with a comprehensive idea of bird species and numbers in the state is by the accurate watching and reporting of many dedicated observers.

### NEWS FROM FORT ROBERDEAU

In memory of Al Burd who devoted so much time and expertise to the nature area of Fort Roberdeau, J.V.A.S. has placed a large observation window in the newly constructed Activities Building at the fort. Outside the window will be shrubbery, trees and a water source, as well as feeders. This will create a wonderful place to watch the birds so that student visitors will have better opportunities for seeing and learning about them.

Dave Kyler, Janet DeMuth, Truth Close, Colette Heller and Peggy Goodman have worked to coordinate the project with the contractor who built the shell of the building in June. Blair County employees will finish the interior as time and funds permit. The building will serve as a resource, year round, for schools to use as an environmental learning center. It will also be available for church picnics, meetings, etc.

The Fort's Director and its Board appreciate recognition of Al Burd's dedicated service in this tangible way. The window will provide pleasure to many and remind us to keep Al's gentle instructional methods and reverence for the outdoors in our minds as we teach.

Other news from Fort Roberdeau: Janet DeMuth has obtained and placed new identification signs on trees and shrubs along the trails. A grant from the Blair Soil Conservation Commission was used to purchase the signs, and to provide new bridges, water diversion systems and base materials for wet sections. County employees and Boy Scouts have done much work in the last year, but work remains to be done


