CANOE CREEK STATE PARK SPECIAL AREAS PROJECT

Juniata Valley Audubon Society vice-president Bill King is coordinating the Pennsylvania Society for Ornithology Special Areas Project at Canoe Creek State Park. This is one of 40 Special Areas Projects taking place in Pennsylvania this year. These are bird censuses of particular public lands which take place several times a year. Their goal is to gather data regarding avian populations during different seasons, thus contributing to the body of knowledge regarding biodiversity in the Commonwealth. At Canoe Creek each participant counts numbers of species and individuals during a four to five hour period in a given area of the park on a preassigned day. The next census will take place on Sunday, 22 November 1992. If you are interested in participating, please call Bill King at 942-7673.

CONSERVATION COMMITTEE NEWS by Paula Ford

JVAS's Conservation Committee met recently to set goals for the year. The committee has decided to investigate the impact of nonpoint source pollution in small watersheds in our area and to investigate the status of several wetland areas, especially those adjacent to industrial sites.

Committee chair, Paula Ford, will continue to work on national issues including oil and gas production wastes. She currently serves on the steering committee of the National Citizens' Network on Oil and Gas Hazardous Wastes. The Network is a coalition of more than 130 national, state, local, and tribal organizations. When the new Congress convenes in January, the Resource Conservation and Recovery Act (RCRA) is due to be reauthorized, and there will be an opportunity for improving the way oilfield wastes are handled.

Paula also attended an Environmental Forum sponsored by DER's Southcentral Regional Office in Altoona on 27 October. The Forum was attended by representatives of several environmental organizations, homebuilders, businesses, and DER staff. Dr. Hugh Archer, the DER regional director for our Southcentral Region (Blair, Bedford, Fulton, Huntingdon, Mifflin, Juniata, Perry, Cumberland, Franklin, Adams, York, Dauphin, Lancaster, Lebanon, and Berks Counties) welcomed the group and introduced each of the staff members who gave a presentation. He also addressed some of the concerns that we raised. Gregg Robertson, Deputy Secretary for Field Operations, gave an overview of DER activities. Leif Ericson, Air Quality Manager, spoke about mammography regulations. Leon Oberdick, Water Quality Manager, spoke about mammography regulations. Leon Oberdick, Water Quality Manager, spoke about unplanned subdivisions and overloaded sewage treatment plants. (This problem is especially relevant in Blair County.) Elmer Knaub, Water Supply Manager,

spoke about the filter rule for municipal water supplies. Francis Fair, Waste Management Manager, spoke about residual waste regulations and the state's clean-up program. A blizzard of interesting handouts was available for those who have room in their filing cabinet which Paula does not, so she took only the dozen or so most fascinating or interesting.

AUDUBON FALL WEEKEND by Stan Kotala

Audubon members from across the Commonwealth attended the Audubon Fall Weekend on October 16, 17, and 18 at Black Moshannon State Park in Centre County. On Friday, October 16, Frank Felbaum, director of Pennsylvania's non-game wildlife programs, discussed the past success stories, present programs, and future projects which have been helped by the Keystone State's Wild Resource Conservation Fund. An outstanding slide show was presented and attendees received a beautiful full-color neotropical migrants poster. We also were introduced to Marci Mowery, the Audubon Council of Pennsylvania's new exucutive director and regional wetlands coordinator.

Roger Fickes, the new director of the Pennsylvania state park system, joined us on Saturday, October 17, to discuss the initiatives set forth in State Parks 2000, the recently completed study regarding the future role of state parks in the Commonwealth. This report was the result of several years of meetings and surveys between the Department of Environmental Resources and the public through which Pennsylvanians overwhelmingly voted to retain the rustic character of our state parks. State parks officials will meet with local community leaders to find ways to protect parks from unsuitable patterns of development in their proximity as well as to create greenways between major population centers and their local state parks.

A new source of funding for environmental groups in the Commonwealth was introduced by Ann Dooley and Chris DeCristafaro. The Environmental Fund for Pennsylvania is a state-wide non-profit tax-exempt organization which enables environmental groups to raise funds from individuals where they work and to educate Pennsylvanians about environmental issues affecting them.

In the afternoon on Saturday we met Michael Robbins, the editor of Audubon, who discussed the direction that the magazine is taking. Audubon is committed to presenting well-researched articles which will allow the magazine to maintain a very high level of journalistic integrity.

Towards dusk Audubon members expored the Black Moshannon Bog Natural Area. A new board-walk was built recently through portions of the park's wetlands, allowing visitors to explore the moister areas of the bog without getting their feet wet. Everyone enjoyed the fall foliage but the gathering darkness and chill drove us back to the cabins for a great spaghetti dinner and social followed by a pot-luck nature slide show.

Walt Pomeroy, National Audubon Society regional vice-president, informed us regarding Audubon's Wetlands Campaign in the mid-Atlantic region on Sunday and thereafter the meeting adjourned. A great time was had by all!

WILD RESOURCE CONSERVATION LICENSE PLATE by Stan Kotala

Frank Felbaum, executive director of the Wild Resource Conservation Fund, has announced the possibility of a Wild Resource Conservation License Plate being made available to the public. This plate would cost \$35 in addition to the annual registration fee. The Wild Resource Conservation Fund would receive \$15 of this fee. This would be a great way for Audubon members to support the WRCF as well as keeping the WRCF in the public eye through a beautiful license plate.

The 93rd annual Christmas Bird Count will take place this holiday season. Approximately 45,000 people will participate, counting birds within designated 15 mile circles from Alaska to Peru. The Juniata Valley Audubon Society will hold its CBC on Saturday, January 2nd, 1993. Our count circle centers on Culp in Sinking Valley. Last year we saw 48 species. Our record of 66 species, set in 1985, was not threatened.

We will meet at the White Oak Hall at Fort Roberdeau at dusk (6:00 P.M.) for dinner. Bring a covered dish of your choice and your own place setting. We'll do a rough tabulation of the day and swap "the bird that got away" stories.
