# "A Summer with the Tides: Fieldwork in the Saltmarshes of NJ" by Carl Engstrom

The saltmarshes of the Mid-Atlantic are a dynamic and harsh environment that are home to some very unique species. This delicate habitat is in constant threat from human encroachment and is now in danger of being lost permanently by global sea level rise. The Saltmarsh Sparrow is found nowhere else in the world and, as a result, is perhaps the bird species most at risk of extinction in the Lower 48. Last summer, Carl was fortunate enough to spend time working in this special ecosystem in New Jersey conducting point counts for the Saltmarsh Habitat and Avian Research Program (SHARP) to gain a better understanding on population levels for various bird species that rely on saltmarshes. This presentation will cover Carl's work and aim to provide a better understanding of saltmarsh habitat and the birds that call them home. A special focus will be placed on the Saltmarsh Sparrow and the threats that they face.

Growing up in State College, Carl has been fascinated by birds his entire life. One of his first experiences with the birding community was helping with the Culp Christmas Bird Count on the Bonta's property with his dad at the age of ten. He has participated in the count every year since. It's an annual tradition that he always looks forward to. In addition to birding for enjoyment, Carl has worked several field jobs with birds over the last few years. He spent two summers in college working with Penn State graduate students studying Wood Thrush nest site selection in Centre, Blair, and Huntingdon Counties. Last summer he worked in coastal New Jersey conducting point counts to census populations of Saltmarsh and Seaside Sparrows. After graduating from Penn State in the spring, he worked out in Montana on a project investigating the impacts of conifer encroachment on nest success in sagebrush nesting bird species. Currently Carl is the inaugural morning flight counter at Dan's Rock along the Allegheny Front in western Maryland working to gain a better understanding on bird migration in the Appalachians. Carl plans to continue bird research in graduate school and hopes to make bird research a career.

# Birding the Bells Gap Rail Trail the first Tues. of each month: 10-noon: 9/6, 10/4, 11/1, 12/6

Join John Carter on the Bells Gap Trail every first **Tuesday of the Month** from 10 am-12 noon while enjoying outstanding views of eastern ridges, the Tuckahoe Valley, and the Bellwood Reservoir. We will stroll 2 miles of the trail that consist of fresh crushed limestone surface. Let's track different bird species we see and have an enjoyable walk. Nocturnal Flight Call Workshop - Live from Plummer's Hollow:

Night of Saturday, Sept. 24 and/or morning of Sunday, Sept. 25, 2022 Did you know that the night skies are filled with migrating birds?

Using a specialized microphone and software, it is possible to detect and identify them by their Nocturnal Flight Calls (NFCs)!

This **by-reservation-only** workshop introduces the complex process of capturing and identifying what is flying during the height of the Fall Migration.

Several options are available: The first part of the workshop starts at 6 PM on Saturday.

You can 1) attend, return home, and come back at 3 AM; 2) stay all night, camping out under the stars, in your car, or under a roof; 3) come at 3 AM.


Where to meet: Park and Ride, East 10th St, Tyrone, PA 16686.

Not the team but the bird! Up to 29 Golden Eagles have been sighted along Brush Mt in the Tyrone area in a single day in early December! A very small number of people will be able to access a private deck in Tyrone with a sweeping view of the Tyrone Gap, to tally eagles - weather permitting.

1. Proposed Rutter's Gas/Convenience Store upslope from Old Crow Wetlands near Huntingdon, Pa. Rutters submitted their application to the Huntingdon Co. Conservation District, and it's being reviewed by DEP.

JVAS members have repeatedly expressed their concerns and opposition at Smithfield Township meetings. We encourage you to attend the monthly township meetings and express your concerns. Township meetings are the first Tuesday of each month, at 6:00 pm. The location is the township building in Smithfield, on the corner of 13th Street and Mt. Vernon Avenue, or 2 blocks south of Rt 26 (Pennsylvania Ave.).

Ask DEP to require an individual permit for this project and schedule a public hearing so our concerns can be raised.

2. Proposed Rutter's Gas/Convenience Store upslope of Sandy Run Exceptional Value Wetlands along Sabbath Rest Road, beside the Days Inn & Suites by Wyndham in Pinecroft, Pa.

The concerns for this Rutter's Store (with parking for 53 trucks) are similar to those in Huntingdon. Stormwater and any hydrocarbon pollution will flow into the wetlands along Sandy Run, classified as a High-Quality Coldwater Fishery. The Pa. Fish & Boat Commission classifies Sandy Run as a Class A Wild Trout stream with naturally reproducing wild trout, thus making it an Exceptional Value wetland. JVAS President John Carter and other local conservation groups participated in a DEP public hearing to share water pollution concerns. A decision from DEP is pending.

3. Anthracite Ridge Wind Project (proposed) impacting four mountain tops in Schuylkill Co.

The Hegins Township Zoning Board denied the application on Jan. 11, 2022, but the developer has appealed to the County Court of Common Pleas. There is a major standoff between the developer and the Fort Indiantown Gap, which maintains that wind turbines will reduce needed air space and put pilots at risk. The Federal Aviation Administration (FAA) has not issued an opinion yet, but the project was recently withdrawn from the PJM Grid application process, so that's good news!

JVAS is having a sticker design contest and we want you to submit your best effort that resembles the mission of our amazing Audubon chapter!


Contest Deadline: Entries must be received no later than December 31, 2022.

#### JVAS and LENCA COFFEE ROASTERS CELEBRATE 8 YEARS AS PARTNERS TO HELP BIRDS



Can you identify these warblers? They are all neotropical migrants that spend most of their lives "wintering" in Central or South America. According to National Audubon, all four have been observed in shade-grown coffee farms. They actually spend a very short time in Pennsylvania and other areas of North America, where they breed and raise their young.

From Left to Right: the Hooded Warbler migrates to Central America. The wintering range of the Black-and-White Warbler extends from Mexico to northern South America. The Magnolia Warbler flies to Central America and the Caribbean, while the Kentucky Warbler winters from Mexico to northern South America.

Many neotropical migrants use shade-grown coffee plantations, since the coffee is grown under the canopy of the forest, providing ample insect food and cover. That's why JVAS partners with Emilio Garcia to help sell his single-origin coffee that is shade-grown in Honduras, using organic practices.

Sun coffee requires pesticides and is grown in plantations where the natural habitat has been destroyed.
